

Local Law No. 2 of the year 2007

Section 1. The Code of the Village of Chester Chapter 29 Alarm Systems, Section 29-16, AUDIBLE

ALARM PERMITS; FEE is hereby renamed AUDIBLE ALARM PERMITS and is further amended by removing subsection 'E' in its entirety.

Section 2. The Code of the Village of Chester Chapter 29 Alarm Systems, Section 29-17, SUSPENSION AND REVOCATION OF PERMIT is hereby removed in its entirety.

Section 3. The Code of the Village of Chester Chapter 29 Alarm Systems, Section 29-10, FALSE ALARM CHARGES is amended replacing subsection 'A' in its entirety with the following:

A. Any owner or lessee of property having an alarm device or system shall pay to the Village a charge for each and every false alarm during an Alarm Permit Year, as follows:

Section 4. Repealer. All Local Laws, Ordinances or parts of Local Laws or Ordinances inconsistent or in conflict with these Ordinance are hereby repealed as to said inconsistencies and conflicts.

Section 5. Severability. In the event that any clause, sentence, section or other part of this Local Law is declared to be invalid, such invalidity shall not affect the remainder of this chapter.

Section 6. This Local Law shall become effective immediately upon filing with the Office of the Secretary of State pursuant to the Municipal Home Rule Law.




